- No free liquids, hay, wood or nuisance odors are present in the soil.
- Soil generated from a virgin Release require TPH analysis only pending confirmation there are no other constituents of concern by an LSP Licensed Site Professional and or QEP Qualified Environmental Professional. Facility can limit on a case by case basis
